# SONGS Public Walking Tour

## Frequently Asked Questions

### 1. What does the walking tour involve?

The walking tour is a 1.5-mile guided tour with several stops inside the Owner Controlled Area of the San Onofre Nuclear Generating Station. Tour participants can get a first-hand view of the plant and learn more about the decommissioning process. The tour route starts at the east turnstiles in Parking Lot 4 and takes about an hour and a half to complete. The route does not take you inside any buildings. **Registration must be completed to participate.**

### 2. What are the requirements to participate in the tour?

Tour participants should be physically capable of walking up and down stairs and hills, as well as standing on their feet for extended periods. Additionally, tour participants must be age 10 or older and minors must be accompanied by an adult. One adult may bring four children as additional guests. Please dress appropriately for the weather and wear comfortable walking shoes. Sunscreen and a hat are recommended.

### 3. How will I know if I have been selected to participate in a walking tour?

Each participant age 18 and older must complete a two-step process: 1) sign up online at [songscommunity.com](https://songscommunity.com); 2) when requested for security purposes, provide the last four digits of the participant's social security number, or a valid passport or residence number for non-U.S. citizens. An SCE representative will follow up with you directly to obtain your personal information to process the security requirement. All information must be received a week prior to your tour date for processing. The final tour date and time will be confirmed when all required information has been processed. **Registration must be completed to participate.**

### 4. I have a group larger than 10 people. What should I do?

We will work with you to accommodate your group. Please sign up online and click the box indicating you represent a large group. We will follow up with you on your request. Please note that we will need to adhere to the same guidance as outlined above. If your group has a large number of children, there must be one adult for every four children on the tour.

### 5. What identification is needed for walking tour participants?

Walking tour participants age 18 and older must possess valid photo identification such as a driver's license, state ID or passport. Guests age 17 and below must be accompanied by an adult. One adult may bring four children as additional guests.

### 6. Can we take photos or video during the tour?

Personal photography or videography will not be permitted during the walking tour, except at one designated point where the tour guide/SCE representative may take a photo using your

camera or phone. Photos may be taken in Parking Lot 4. By participating in the SONGS Public Walking Tour, you and your guests grant Edison International, its affiliates, and their legal representatives, the irrevocable and unrestricted right to: (i) take photographs or video that may contain your likeness (“photographs”); (ii) to use, copy, modify, adapt, distribute, publish, display, and otherwise use, in whole or in part, the photographs for editorial, trade, marketing, advertising, and any other purpose and in any manner and medium; and (iii) to copyright the same.

### **7. What is the dress code?**

Participants should be dressed appropriately for an industrial facility and the weather that day. Due to the limited route of the walking tour, tank tops and shorts will be allowed and good walking shoes should be worn. The following types of shoes are prohibited: sandals or flip-flops; open toes, open heels or open sides; heels measuring more than two (2) inches in height; heels less than one (1) inch in diameter that can become wedged in grating or in holes. **No one will be allowed on the tour if they are wearing incorrect footwear.**

Sunscreen and a hat are recommended.

### **8. Will drinks or food be available to tour participants?**

Water will be provided.

### **9. How can I prepare for a successful visit?**

Arrive at least 20 minutes prior to your scheduled tour time. This will allow everyone to register and gather with your guide to begin the tour on time. There are no restroom breaks along the tour route. We have a tight schedule and want to ensure everyone scheduled gets the same opportunity to tour. Make sure you and your guests bring the necessary identification. Appropriate shoes and attire are required. There are no exceptions. Please dress appropriately for the weather that day. Sunscreen and a hat are recommended.

### **10. Can I leave my 9-year-old in Parking Lot 4 while my older child and I take the tour?**

No, child care services are not provided for the SONGS Public Walking Tour. Adults will be required to remain with their children throughout their visit.

### **11. Will there be more tour dates?**

Yes. Check [www.songscommunity.com/tour.asp](http://www.songscommunity.com/tour.asp) for available dates. Tours are generally offered twice per month – one on a weekday and one on a weekend. Additional dates are posted to the website as they are scheduled.
